## Working for Inclusion in Europe The project

Working for inclusion is a programme which has been examining the role of early childhood education and care services and their workforce in reducing child poverty and promoting social inclusive societies. It has encompassed a major EU-wide research programme and a series of study visits, seminars and conferences to encourage discussion and debate. Funded under the EU progress programme with support from the Scottish Government, it has brought together politicians at local, national and at an EU level with policy makers and practitioners.

### Children in Scotland

Children in Scotland is the membership body for all those working with and for children, young people and their families throughout Scotland.
